Fidelity Guarantee – the level of fidelity guarantee cover was insufficient in light of bank balances held at 31 March 2008 and the amount of precept then subsequently received in April 2008	The Council should consider the level of insurance cover and set it at a level that would protect the council against potential loss.	NOTED – to be adjusted at renewal in April
Expenditure Powers – S137 incorrectly used – donations were made to a local festival which could have been authorised under S145 of the Local Government Act 1972, provision of entertainment and support of the arts.	The Council must ensure in future years they review the list of statutory powers available to establish if a power exists before relying on S137 to authorise payment.	NOTED for future application
Expenditure on Christmas trees/lights could have been authorised under S144 or S145 of the Local Government Act 1972, powers to provide and encourage the use of facilities or provision of entertainment and support of the arts.	We recommend that the statutory power being used to authorise expenditure is recorded alongside the item to demonstrate the council or meeting has properly followed their standing orders and financial regulations.	NOTED – to be implemented immediately
