#### 7. FURLAND ALLOTMENTS

#### (a) Licence renewal

At the request of the Allotment Association an additional clause has been added to the Licence Agreement as follows:

4.1.15 The Association must take action against anyone who produces or displays material which people may find offensive or anyone who threatens, assaults or victimises someone. If a tenant causes or takes part in discriminatory behaviour, harassment or intimidation he/she will receive a written warning, on receipt of three written warnings the tenant will not be allowed to keep their allotment plot. Tenants are responsible for other people they allow onto the allotment site. If a tenant or their visitor has been involved in anti-social behaviour on the allotment site, the Association may terminate the tenancy agreement.

Members to **APPROVE** the inclusion of this clause.
