## **1925 CORRESPONDENCE**

# (a) Dorset Council – FOOTPATH 5 – Public Path Diversion Order 2019

Members **NOTED** correspondence received from Dorset Council which advised an Order in respect of Footpath 5 had been made on 5<sup>th</sup> July 2019 and advertised on 19<sup>th</sup> July 2019. However with two outstanding objections to the Order, it couldn't be confirmed because the development had substantially been completed therefore the Secretary of State had no power to confirm the Order.

The Order had therefore been formally abandoned and the route of Footpath 5 remained unchanged as shown along its current definitive line on the Order. The applicant had been advised to submit an application to Dorset Council to divert Footpath 5, if an application had not been received within 6 months Dorset Council would take enforcement action to reopen the definitive line of the footpath.<sup>1</sup>

# (b) Dorset Council – Application for Definitive Map Modification Order – Beaminster & Cheddington Parishes – T753

Members **NOTED** correspondence received from Dorset Council which advised an application had been received for a definitive map modification order to modify the definitive map and statement of rights of way, the application if successful would alter Dorset Council's record of public rights of way by adding a Byway Open to All Traffic in the parishes of Beaminster and Cheddington.

An investigation into this application had not yet begun but in the meantime any relevant evidence should be submitted to Dorset Council for inclusion in the report.
