626 MINUTES OF THE FINANCE & GENERAL PURPOSES COMMITTEE MEETING HELD ON 20TH DECEMBER 2022

630 GRANT APPLICATION

(a) Beaminster Royal British Legion

Members considered a request received from Beaminster Royal British Legion for a financial donation to cover the cost of the HMS Heron Volunteer Band for 2023 Remembrance Day Parade. **RESOLVED** to award a grant of £200

631 COMMEMORATIVE TREES

This item had been referred from Community Engagement Committee to consider the proposal to plant trees in the square to commemorate the late Queen's Jubilee and the coronation of King Charles III. A quotation had previously been approved for the purchase of two Betula Utilis (Himalayan White Birch) trees in the sum of £349.99 together with the cost of top soil £99.99 and compost in the region of £42.00

Member consider three quotations received for the supply of two hardwood planters **RESOLVED** to accept the quotation from Fat Leaf, Beaminster in the sum of £1,581.76.

RESOLVED to utilise a legacy left to the Council by a former Town Clerk (Mrs Blair) to fund one, an approach would be made to Market House & Tolls Trust for funding for the other.

632 NEIGHBOURHOOD PLAN

Following the appointment of an external consultant to support the preparation of the Beaminster Neighbourhood Plan members **RESOLVED** to form a Working Group with Cllrs Monks, Langridge and Turner expressing an interest. **AGREED** to make an approach to a number of community groups within the town with a view to recruit interested parties to the Group.

(a) IT and telephone system

Member had previously been circulated with the Town Clerk's confidential report detailing the arrangements put in place to rent and equip office space within Beaminster Co-working for use as Town Clerk's office. **RESOLVED.**

The Town Clerk also advised members of a meeting that had taken place with the Councils IT provider at which the updating of the Councils telephone system had been discussed following which a quotation had been received in the sum of £68.86 per quarterly and a one off discounted cost of £100 for installation. **RESOLVED** to **ACCEPT** the quotation.

(b) Street Names

The Town Clerk advised the developer of the site at Broadwindsor Road had responded with their preferred street names from those submitted by the Council, members **NOTED** the names chosen acknowledged the Town's Flax industry heritage
