### 2079 HIGHWAYS ISSUES

The following issues were raised:

- **Stoke Road** continuation of a problem with mud on the road which washes into drains in heavy rain.
- Tunnel Road pedestrian walking on grass verge had, over time created a defined path on the grass verge, the Town Clerk was asked to enquire of Dorset Council if it could be hard surfaced.

## 2080 ROAD SAFETY ISSUES

The following issues were raised:

- The results of the traffic survey were awaited.
- Mini roundabout at Clay Lane/Tunnel Road the Town Clerk to enquire of Dorset Council as to whether the roundabout could be better defined to slow traffic down on Tunnel Road as visibility was poor when entering the roundabout from Clay Lane or as an alternative a mirror to enable motorists to see vehicles approaching on Tunnel Road.

## 2082 PUBLIC BODIES (Admission to meeting) ACT 1960

Members **RESOLVED** that public and press be now excluded from the meeting whilst discussion took place on the following items on the grounds that publicity would be prejudicial to the public interest by reason of the confidential nature of business to be transacted in respect of consideration of a financial purchase.

## 2083 REPLACEMENT OF CB3

Cllr Turner reminded members that he had previously expressed his concern at the deterioration in condition of the current CB3 bus; also the difficulty of obtaining and cost of parts. In recent weeks he had endeavoured to source a replacement vehicle and was pleased to report that a suitable vehicle had been identified.

Cllr Monks advised that during the Christmas break he had submitted a number of grant applications to enable the Council to purchase a replacement mini bus, he was delighted to announce that an application to Dorset Council had been successful and the Council had been awarded a grant of £8,000 to be paid in the 2024/2025 financial year and a further £8,000 grant to be paid in the 2025/2026 financial year. An application submitted to South Western Railway's successful Customer and Community Improvement Fund (CCIF) will be considered in March.

In addition to the grant applications Cllr Monks advised it was intention to prepare a crowd funding bid to launch at Easter.

Discussion ensued with regard to financing the purchase in the short term pending payment of the first instalment of the grant funding from Dorset Council; having reached a solution members **RESOLVED** to purchase a replacement vehicle at a cost in the region of £17,000
