The Council's period of public rights ran for 30 working days (from 17/06/19 to 26/07/19), but the relevant information (ss1 and 2 of the AGAR, a note that this information is unaudited, and a note of how electors may exercise their public rights) was not published on the Council's website until 30/06/19. The information is still on the website at 20/07/20. The External Auditor has confirmed that the relevant information should be published on the Council's website at least one day before the start of the public rights period, and that it should remain on the website for the duration. Consequently I have assessed this test as a 'fail'.
