2178 APOLOGIES FOR ABSENCE

Apologies were received from Cllr Anderton and Cllr Tuff.

2179 MINUTES OF THE PLANNING ADVISORY & HIGHWAYS COMMITTEE MEETING HELD ON 3RD SEPTEMBER 2024

Members having previously been circulated with the minutes of the Planning Advisory & Highway Committee meeting held on 3rd September 2024 were confirmed and signed by the chairman as a correct record.

2180 DECLARATIONS OF INTEREST

No declarations of interest were received.

2181 PLANNING ISSUES

(a) To CONSIDER the following PLANNING APPLICATIONS:

1. P/FUL/2024/04324

BARROWFIELD, BROADWINDSOR ROAD

Excavation and installation of an attenuation pond and 2 No. headwalls with fencing to the perimeter. Existing attenuation channel of 449 Sq m to be increased.

Recommend Approval the proposal would not be detrimental to the area and improve drainage.

2. P/FUL/2024/04405

OFFICES, 9 CHURCH STREET

Change of use from workshop/office (use class E) to residential dwelling (use class C3).

Recommend Approval the change of use would not have a detrimental impact the residential dwelling.

3. P/TRC/2024/04605

HONEYSUCKLE FARM, TUNNEL ROAD

Retain replacement summerhouse, decking and jetty

Recommend Approval.

4. P/HOU/2024/04898

CHERRY COTTAGE FARM, CHERRY COTTAGE

LANE

Extend existing 1 and ½ storey utility room extension

Recommend Approval the proposed extension would not have a detrimental impact on the area

Granted with 2 conditions.

3. P/HOU/2024/04144

38 CULVERHAYES

Construction of external walls beneath existing roof that connects main house to previous extension

Granted with 3 conditions.

4. P/LBC/2024/04046

6 WHITCOMBE ROAD

Proposed internal alterations to bathroom facilities.

Granted with 2 conditions.

5. P/FUL/2024/03731

6 NORTH STREET

Alterations to cladding of part of existing industrial buildings – first floor

Granted with 3 conditions.

(c) PLANNING REFUSALS

Members **NOTED** refusal of the following planning application although outside the parish boundary representation on the application had previously been made direct to the Council.

P/FUL/2023/04018

LAND SOUTH EAST OF DOWN FARM

Retain open fronted timber shelter, 2 No small wooden barns, wooden chicken coop and goat house. Reinforcement of existing track.

Refused – insufficient information to adequately assess the impact of Dorset AONB

2183 PUBLIC RIGHTS OF WAY

No issues were raised.

2184 PUBLIC TRANSPORT

Members **NOTED** that no major issues had been identified during the recent CB3 MOT and service.

Cllr Turner advised some discussion had taken place with officers from Lyme Regis Town Council with regard to the possibility of utilising the CB3 vehicle when not in use during the week to provide a town bus service in Lyme Regis. A response was awaited from Lyme Regis Town Council.

2185 HIGHWAYS ISSUES

The Town Clerk was asked to report hedge growth obscuring speed limit and other road signs within the area to Dorset Council.

2186 ROAD SAFETY ISSUES

(a) 20mph Speed limit

No further update received from Dorset Council.

2187 NEIGHBOURHOOD PLAN

Members expressed their disappointment that the planned presence at the Beaminster Big Green Day event on 28th September 2024 had not transpired. Following discussion Cllr Gillings **AGREED** to compile a draft questionnaire for circulation within the Town.

2188 COMMUNITY RESILIENCE

An informal meeting had taken place attended by Cllr Gunning and flood wardens on 3rd October 2024.

The Council had now submitted its 2024 Community Sandbag Audit to Dorset Council for their advanced knowledge and planning.

Cllr Gunning had assumed administrative control of the Flood Wardens WhatsApp group, together with office staff he would continue to liaise with wardens. The continued success of the Resilience team would very much depend on having a core of 2-3 dedicated Councillors who would be on-hand 24/7 during an emergency to ensure that previous work can continue along the same trajectory.
