2201 ROAD SAFETY ISSUES

(a) 20mph Speed limit

Following the recent speed surveys at two locations on Bridport Road Dorset Council have forwarded the details of our application to Dorset Police for their consideration.

The proposal does not include Gerrards Green because the mean speeds (29mph) are too high to comply with unless additional traffic calming measures are introduced, the additional measures could be the siting of a SID.

To **CONSIDER** the installation of a SID in this location to enable an extension to the 20mph to include the Gerrards Green area.

2202 NEIGHBOURHOOD PLAN

Members had previously been circulated with a copy of a draft survey compiled by Cllr Gillings, the Town Clerk advised that subsequent to its circulation a number of minor amendments had been made however those changes did not have an overall impact on the content. Members expressed their gratitude to Cllr Gillings and **RESOLVED** to publish and circulate to as many households as possible within the town; copies to be made available in strategic locations within the town.
