**Phase 3** – these schemes have received the authority to proceed to Stage 2: Public Consultation. It is important to note that there is a limited time period to implement the

scheme once legal powers have been granted. Therefore, it would be unwise to proceed with the public consultation until a delivery timeframe has been established.

Beaminster has reached Phase 3, it is acknowledged that there will be some frustration that the exact timetable cannot be provided at this time, however delivery of the 20mph policy is of high priority to Dorset Council. Individual progress updates will be provided as soon as available.
