**2315 MEMBERS PRESENT:** Cllr Gillings (Chairman), Cllr Corbett, Cllr Gunning, Cllr Turner and Cllr Woods: also Christine Bright (Town Clerk) and one member of the public.

**2316 APOLOGIES FOR ABSENCE**

Apologies were received from Cllr Anderton, Cllr Biggs and Cllr Dawkins.

**2317 MINUTES OF THE PLANNING ADVISORY & HIGHWAYS COMMITTEE MEETING HELD ON 5<sup>TH</sup> AUGUST 2025**

Members having previously been circulated with the minutes of the Planning Advisory & Highway Committee meeting held on 5<sup>th</sup> August 2025 were confirmed and signed by the Chairman as a correct record.

**2318 DECLARATIONS OF INTEREST**

Cllr Woods declared a prejudicial interest in agenda item 4 (a) – Application No. P/TRC/2025/05006 – Daniels House, 29 Hogshill Street.

**2319 PLANNING ISSUES**

(a) To **CONSIDER** the following **PLANNING APPLICATIONS:**

**1. P/PABA/2025/04332**

**GROVEFIELD, WEST DIBBERFORD**

Erect agricultural barn for storage of hay

Recommend approval, the development would not have a detrimental effect on the amenity of the area.

**2. P/TRC/2025/05006**

**DANIELS HOUSE, 29 HOGSHILL STREET**

G1 – Beech x 3 – reduce overall crown by up to 3.5m and thin internally by 15%, crown raise to 3.5m off ground level and remove overhanging branches from southern boundary.

The committee did not consider or comment on this application.

**2320 CORRESPONDENCE**

**(a) Dorset Council – Dorset Local Plan Consultation**

Members had previously been circulated with details of the Draft Dorset Local Plan consultation documents in respect of Beaminster and the wider environs.

Following initial discussions where it was **AGREED** to submit a corporate response, members were asked to feed back to Cllr Turner who would formulate a response for consideration at the next Planning Advisory, Highways and Resilience Committee meeting in October.

**(b) Dorset Council – Local Transport Plan Consultation**

Members had previously been circulated with details of the Draft Transport Plan consultation documents in respect of a new Local Transport Plan 2026 to 2041 which would set out the vision for improving transport and travel over the next 15 years.

**2322 HIGHWAYS ISSUES**

**(a) Overgrown vegetation**

Cllr Turner expressed his frustration that, despite previous complaints, vegetation obscuring road signs had not been cut back by Dorset Council.



**2323 ROAD SAFETY ISSUES**

**(a) Speed restriction A3066**

The Town Clerk reported, with regard to the introduction of a 50mph speed limit between Beaminster and Mosterton, Dorset Council had advised the section of the A3066 in question (South Dibberford Farm) was within Broadwindsor Parish. As suggested by Dorset Council the Clerk had consulted both Broadwindsor and Mosterton Parish Councils, a response awaited.
